# WEBINAR CONTENT

\* First Presentation: According to the UK's National Crime Agency, 'there are no exact figures' but 'there is a realistic possibility that the scale of money laundering impacting the UK annually is in the hundreds of billions of pounds.' With this 'possibility' in mind, this presentation will begin by considering why the UK has attracted so much illicit finance from overseas, including the Republic of Cyprus ('Cyprus') and Russia. Conscious of the ties that connect the UK to Cyprus, the presentation will then identify some of the Acts of Parliament, Regulations and cases at the core of the AML and Financial Sanctions Regime ('the Regime') in post-Brexit England. The Regime now embodies a 'package' of Russian sanctions which, on 22 February 2022, was described as 'draconian' by Boris Johnson MP, the then British Prime Minister; the Regime also embodies the Economic Crime (Transparency & Enforcement) Act 2022, which received Royal Assent on 15 March 2022, plus the UK Sanctions List as updated on 4 October 2022 among other dates. The presentation will question features of the Regime which are hard to reconcile with the rule of law, professional ethics or basic tenets of the lawyer-client relationship such as client confidentiality. Throughout, the presentation will offer practical suggestions aimed at lawyers in Cyprus with cases or clients linked to the UK.

\*\* Second Presentation: The worldwide fight against money laundering plays an important part in promoting transparent as well as sound business practices that contribute to a sustainable global financial system resting on the rule of law. Consequently, AML compliance and beneficial ownership transparency have become integral to the modern financial services industry, affecting the day-to-day practices of lawyers, accountants and bankers alike. At the heart of this fight is a need to ensure that compliance practices are governed by balanced and proportionate legislation that achieves its purpose while at the same time guaranteeing the fundamental rights of citizens and upholding the rule of law. In recent years, however, concerns have been raised that the rapid implementation of compliance legislation and the lack of public debate connected thereto have each contributed to the undermining of fundamental rights. There are even cases where the compatibility of transparency with the right to privacy and data protection has been brought before national courts and the Court of Justice of the European Union. This presentation will draw attention to these matters and their practical implications for lawyers in the Republic of Cyprus. The presentation will also analyse some of the main arguments, both in the public debate as well as in recent court cases, calling for a more defined line to be drawn between the need for transparency and the right to privacy.

# The webinar will touch but not focus on Counter-Terrorist Financing and end with an open discussion.

**TARGET AUDIENCE** This Webinar will be of interest to everyone, but it is primarily aimed at members of the legal profession, trainee lawyers and law students in Republic of Cyprus. This Webinar may also appeal to members of the legal profession, trainees and law students in other jurisdictions.
